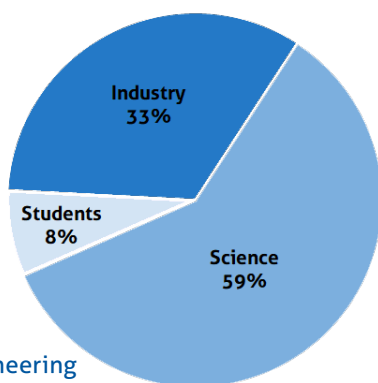

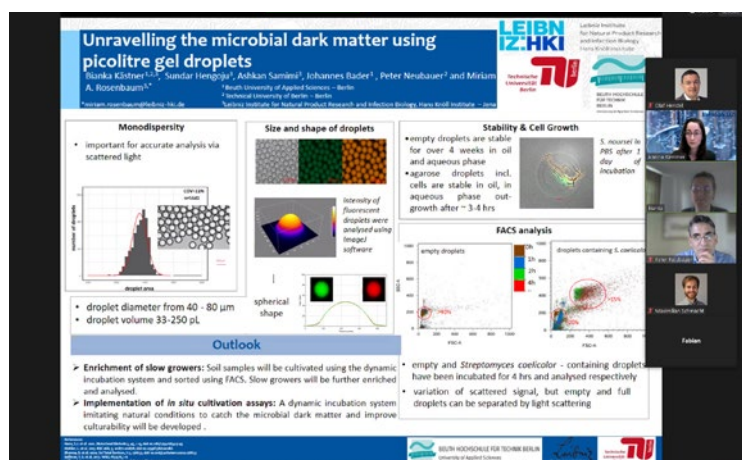

## 4. Services rendered by the IfGB

- Placement of your company logo on the reverse cover page of the symposium programme folder. Format approx. 35 x 20 mm, coloured. We cannot guarantee the imprint for logos handed in after this deadline. No claim for a partial reimbursement of the participants' fees is constituted in this case.

The exhibitor has no right to a rental fee abatement if he does not make use of the services covered by the rental fee.

## 5. Registration and admission

The registration has to be carried out in writing using our registration form. The admission by the IfGB is granted by means of requesting the space rate. The rental agreement becomes effective once the invoice is made out.

## 6. Stand assignation

The stands are assigned on the spot in arrangement with our personnel. The exhibitor has no right to a predefined position. The organiser reserves to himself the right to make a subsequent charge if the booked stand size is exceeded.

## 7. VAT, terms of payment

Since the service is rendered in Germany, the VAT rate is applied. This rate amounts to 19 %.

The exhibitor will be sent an invoice for the space rate

together with the stand confirmation before the start of the event. All amounts will have to be paid into one of accounts of the VLB Berlin before the start of the event. If payment is effected in foreign currency, possible foreign exchange fluctuations and costs are charged to the account of the exhibitor.

## 8. Co-exhibitors

The exhibition space is left to the contracting party as a whole unit exclusively. Any sublease is subject to prior consent of the organiser.

## 9. Rescission of contract

A service charge in the amount of 150 € plus VAT is payable for registrations not withdrawn at least 6 weeks before the start of the event. From 21 days before the start of the event on, the total amount will be charged. The date of receipt of the declaration of rescission by the IfGB is relevant for the validity of this declaration. A change of participants is possible.

## 10. Stand design

Design and setup of the stand are subject to the technical guidelines, effective laws, safety regulations and regulations of the authorities. In general, it has to be observed that any nuisance or disturbance to other exhibitors, or visitors is avoided. The exhibitor is fully responsible for the safety of all constructions and exhibits and subject to accountability if necessary. Sound reproductions are undesired. Once the event has finished, the exhibition space will have to be returned in its original condition. The exhibitor is liable for any damages caused on halls, stands, and the rented stand equipment. (also see point 13)

## 11. Setup and opening hours

Exhibitor move-out	March 31, 14:30 – 18:00

Times are subject to change.

Please take into account that the exhibition will be located in the entrance hall of a building with public access!

## 12. Performance provisos

If the IfGB cannot perform the event due to unforeseen occurrences or an insufficient number of participants, the exhibitors will be notified without delay. The IfGB will abandon the claim to the agreed space rate. If the IfGB has to stop, or shorten the event due to Acts of God, the exhibitor will have no right to claim a reimbursement or remission of the space rate.

## 13. Liability and insurance

The exhibitor is liable for any damages to others caused by himself, his personnel, his representatives, or assistants in the context of the company presentation including damages to buildings and exhibition facilities. If the IfGB is held accountable by third parties for damages caused by the exhibitor, the exhibitor will indemnify the IfGB from such accountability, particularly in case of a violation of industrial property rights. It is for the exhibitor himself to care for adequate insurance protection.

As to the exhibitor, the IfGB is liable exclusively for damages that have occurred due to gross negligence or intention of its institutions or assistants. In particular, the IfGB shall not be liable for damages occurring due to fire, water, ex-



plosion, storm, or other forms of force majeure, or violent assaults, theft, burglary, housebreaking, failure of public service installations (such as electricity, gas, water supply) and similar causes unless these can be put down to gross negligence or intention on the part of the IfGB, its institutions or assistants. This is also valid for damages caused in the context of the opening hours, in particular by visitors to the event, other exhibitors, their representatives, etc). The IfGB shall not be liable for loss resulting from theft, even if the access to the event is only permitted for participants in the event.

#### 14. Rules of the house

In the context of the trade exhibition of the IfGB symposium, the house rules of the congress venue are obligatory and have to be observed. In case of failure to comply with these rules, the IfGB shall have the right to claim compliance with these guidelines, or claim the removal of the objectionable constructional systems and fixtures until the start of the exhibition, or thereafter as necessary. Moreover, the IfGB shall have the right to arrange for the necessary workings to be done on its own behalf. Costs arising from such proceeding are payable by the exhibitor. Claims for compensation - of whatever kind - shall be excluded in any case.

#### 15. Assertion of claims

Any claims on the part of the exhibitor have to be asserted in writing to the IfGB until the last day of the event at the latest. Claims asserted at a later date shall not be considered.

#### 16. Picture and sound recording

The exhibitor has the right to take picture and sound recordings of his own stand, or his exhibits during the opening hours of the event. The IfGB has the right to take picture and sound recordings of individual exhibits for documentation purposes, or publication on its own behalf. This also applies to persons recorded in this context.

#### 17. Visitor information during the trade event

The distribution of brochures or other information about exposed products outside the rented stand is not permitted without explicit consent of the organiser. This also applies to visitor interviews. Manual sale at the stand is permitted. The information measures have to comply with the purpose of discussion about the products exposed. Information measures which may violate legal provisions of any kind, or may include ideological, religious, or political content are not permitted within the premises of the exhibition. The IfGB is entitled to prohibit the issue of information material which may give, or has already given reason to complaint, and seize any such material as may be existent for the term of the event.

#### 18. Miscellaneous question of law

The IfGB is entitled to terminate the agreement without notice,

- If it is proved by means of the presentation of a Court decision that the exhibitor has violated the provisions stipulated in the patent law, competition law, or any other law of any kind by the nature of his exhibition, or his exhibits,
- if the exhibitor, in spite of a request by the IfGB, does not clear offences against the conditions of participation without delay,
- if the exhibitor vigorously interferes in the regular course of the exhibition, or the domestic peace.

After notice of termination of agreement, the IfGB has the right to close the stand of the exhibitor and have it disassembled assigning the costs to the exhibitor's account. The exhibitor has no claim to a reimbursement of the payments he has made.

#### 19. Final clauses

Agreements which may amend or deviate from these conditions of participation must be in written form in order to be effective. This also applies to the abolition of written form requirement. During the term of the event including the setup and disassembly time, the exhibitor is on the entire premises subject to the domestic authority of the IfGB, or the congress venue, respectively.

Should one or various clauses of these conditions of participation be ineffective or inexecutable, the validity of the other clauses will remain unaffected thereby.

Furthermore, the General Terms and Conditions of the VLB/IfGB will be applied.

#### 21. Legal venue

Any claims arising from the contractual relationship will be exclusively settled before a competent Berlin court of law. Any disputes will be settled according to German law.

#### 22. Pandemic precautions

All precautionary measures required for the Covid-19 pandemic at the time of the event are binding to all participants.
